

Report on Transportation Department Internal Problems

Mr. Jenne stated that on October 1, he had appointed a task force to look into grievances within the Transportation Department, interview employees, and make recommendations for solutions. Mr. Jenne outlined the problems had had found in the department and said he had discussed solutions with Mr. Pappas. Mr. Pappas had not agreed with the assessment of the problems as outlined by the task force and Mr. Jenne, and could not in good conscious take the approach decided upon by Mr. Jenne. He tendered his resignation effective November 30, which Mr. Jenne reluctantly accepted. Because he believed Mr. Pappas' technical expertise necessary in planning and budgeting of the systems operation for 1977-78 and beyond, Mr. Jenne has requested and Mr. Pappas had agreed to provide technical service to the town on a contractural basis until April 1977. Mr. Jenne then assigned Mr. Shipman the duties of organizing and beginning the process of solving the internal problems in the Transportation Department. He will remain on this assignment until December 17, at which time Mr. Bartosiewicz will be assigned Acting Transportation Director until a new Director can be recruited.

There being no further business to come before the Board the meeting was adjourned at 12:52 p.m.
