ADJOURN THE MEETING. THE MOTION PASSED UNANIMOUSLY, (8-0).

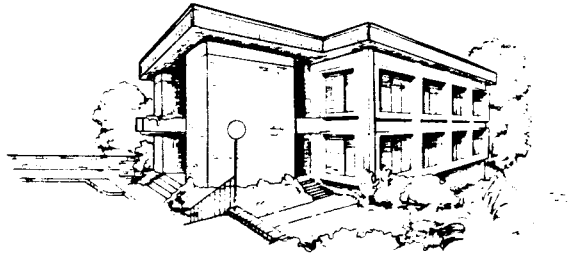


